<u>GIFTS THROUGH YOUR WILL</u> One of the most common ways people choose to leave legacy gifts to their Parish or the Diocese is through a bequest made in their Will. There are several compelling reasons people leave estate gifts to the Church:

Give a transformational gift: Through an estate gift, many people can make significant contributions to their Parish or the Diocese – even people of modest means. The impact that your gift can have on the Church can be truly remarkable, and leaves a legacy beyond your lifetime.

Enjoy significant tax benefits: By including charitable gifts in your Will, you can eliminate significant taxes payable upon your death. In this way, you can ensure that your estate plan will provide for your loved ones as well as your family of faith. Engaging the services of professional advisor is the best way to ensure your estate plan is effective and that your wishes are fulfilled.

In the end, leaving an estate gift to the Church honours the sacred relationship of faith the Church has nurtured during our lifetime, and returns to the Lord some of the abundance provided to us.

GIFTS OF SECURITIES Donating stocks or mutual fund shares is one of the smartest ways to support the Church while realizing significant tax savings. When you give a gift of shares to a registered charity, there are no capital gains taxes applied to the fully realized amount of the gift. In this way, the Church receives the full value of the securities, you receive a tax receipt for the full

value of the gift, and you pay no capital gains tax on any increase in the price of those donated securities.

If you are considering making a gift to your Parish or the Diocese and you own appreciated securities, you may want to consider making this gift through this method. Also, if you are considering selling all or a portion of your investment in securities that have appreciated significantly, you may want to consider donating all or a portion to your Parish or the Diocese. This can allow you to make a meaningful gift to the Church, while also eliminating the capital gains tax you would have otherwise had to pay on the balance of the securities you plan to sell.

MEMORIAL GIVING Making a memorial gift is a special way to honour the memory of a deceased loved one. When a deceased family member or friend was a person of faith, a gift to their Parish or the Diocese is a meaningful way to honour what was most special to them. To make a memorial gift in honour of a loved one, visit our memorial giving page. The giving page allows you to send an electronic card to the family of the deceased, or you can elect to have the Diocese send a card on your behalf. The card acknowledges that a gift has been made in honour of the deceased, however the amount of the gift is never disclosed. Many people also consider including in their estate plans the suggestion of memorial gifts to their Parish or the Diocese in lieu of flowers. This is a powerful way to ensure that something that mattered deeply to you receives gifts that will truly make an impact after you are gone. When a loved one dies, family members are understandably often too distraught to consider including a charitable destination for memorial gifts in the obituary of their loved one. By outlining your wishes to your family, vou can ensure your Parish or the Diocese receive gifts in your honour to help accomplish the mission entrusted to us by Christ. GIFTS OF LIFE INSURANCE Giving a gift through life insurance is a unique way to provide the Church with truly meaningful support in a very economical way. Gifts of life insurance allow people of all means to make truly remarkable gifts to their Parish or the Diocese. There are three different ways to give a gift of life insurance:

Purchase a new policy, and name your Parish or the Diocese as the owner and beneficiary. The premiums you pay on the policy are then deemed a charitable donation for which you receive a tax receipt.

Donate an existing policy that you no longer require. Once you assign the policy to your Parish or the Diocese, its cash value qualifies as a charitable donation for which you receive a tax receipt. Likewise, any ongoing premiums you pay are considered donations and are eligible for tax receipts.

Name your Parish or the Diocese as the beneficiary of an existing policy over which you maintain ownership. Upon death, a tax receipt is issued to your estate and the payment issued to your listed b
